# MTB Exams Awards in Music Performance (Graded Exams 1-8 plus Pre-Grades)

# The qualifications' objective

MTB Exams Awards in Music Performance (Grades 1-8 plus Pre Grade Introductory and Pre Grade Higher) are intended to provide targets to enable candidates to develop their mastery of the skills and knowledge required to play and perform on musical instruments or as a singer, from a very basic to advanced level.

With these qualifications, the Music Teachers' Board aims to increase accessibility to graded instrumental music exams by enabling professional instrumental music teachers to oversee and verify audio recordings of examinations for their students or for candidates to record and submit video recordings without the need for a teacher to be present. These graded instrumental and vocal music examinations are submitted online and marked by an MTB Exams' specialist examiner. This is designed to remove some of the barriers candidates and teachers sometimes encounter when taking graded music examinations. The nature of delivery of our qualifications means that our qualifications are available to candidates of any age, in any location worldwide at any time, without the need to enter a long time in advance or adhere to visiting examiner dates or limited exam periods. We also have a Reasonable Adjustments Policy (available via our website) to further maximise accessibility to our qualifications.

#### Regulation

MTB Exams (The Music Teachers' Board) graded awards in Music Performance are regulated in England by Ofqual (The Office of Qualifications and Examinations Regulation).

Recognition by Ofqual is a mark of quality – it shows that as a board we meet their rules and requirements and are able to combine expertise in assessment with effective operational delivery. In turn, this provides assurance that the learners who have taken our Ofqual regulated qualifications have the required level of knowledge and skills in the relevant subject area.

### Who may submit our qualifications

These qualifications are designed to enable professional instrumental, vocal and music teachers to oversee, verify and submit graded practical or performance examinations in audio/video *or* to allow candidates to record and submit video recordings of themselves without the need to have a teacher present. There is no visiting examiner and the candidate's recording may be made during a normal lesson time or at any other time on any day of the year. Candidates have up to 1 year from making an entry to submitting it to MTB Exams.

This means that professional music teachers or organisations employing professional music teachers (such as schools or music services) may register to oversee, verify and submit audio recordings for marking or candidates can enter and submit video recordings themselves. We define a professional instrumental or vocal teacher as someone who earns all or part of their income from either instrumental, vocal or classroom music teaching. To be able to oversee and verify one of our graded qualifications, organisations such as schools or music services may register as a centre on behalf of their staff, or teachers may register as an individual instrumental/vocal teacher.

Organisations or teachers not based in the UK will automatically be required to use video recordings and will need to apply to be eligible to use audio. Not all examinations overseen by a teacher or organisation will be eligible to use audio recordings.

Teachers or candidates submitting our qualifications must adhere to our rules, regulations and policies which are available to view on our website. Crucially, recordings must be made in one single unedited take to replicate a live performance and not using multiple recordings. To facilitate this, MTB Exams offer an app allowing the recording and submission process to take place using just a phone or tablet.

#### The Specification

This specification provides the information required to help Teachers, Centres, Parents and Candidates to prepare for our qualifications and facilitate their delivery. It should be read along with the syllabuses which are available via the website.

## **Specification Review**

The specification is valid from September 2023 and will be reviewed in September each year. The specification may be updated from time to time and the most recent version will be available at all times from the website.

#### **Specialisations**

These qualifications allow candidates to specialise in the following:

Singing, Contemporary Singing – However, not every specialisation is available at all grades. Please see the syllabus for each specialisation for details.

#### What will be assessed

MTB Exams offer two routes to our graded qualifications.

Route 1. Practical Grades

Route 2. Performance Grades

#### **Practical Grades:**

The assessment has three sections all of which are assessed separately.

- 1. Recital (Accuracy/Expression/Technique) This is the performance of compositions or arrangements and the skills being assessed here are the ability to play the correct notes and rhythms fluently and the tempo and intonation. Also, the understanding of the appropriate stylistic expectations of the music, expressive elements such as dynamics and phrasing plus any relevant technical ability required to successfully convey the music to an audience such as tone quality, breath control, bow control, shifts across strings, clarity and quality of articulation, other particular techniques relevant to the piece being performed, staccato, legato, accents, technical control of passagework etc.
- 2. **Technical Section** This assesses the development of particular techniques relevant to the specialisation such as tone, articulation, fingering, bowing patterns, playing patterns in a variety of keys and modes, slurring etc through exercises specifically designed to test these elements as well as scales and arpeggios and chords as appropriate to the chosen specialisation.
- 3. **Musicianship** This assesses <u>Reading Skills</u>: the understanding of and ability to read rhythms in a variety of time signatures, through prepared clapping of rhythmic patterns against a regular pulse at a variety of tempi including crotchets, quavers, semiquavers, minims and semibreves plus dotted rhythms, swung rhythms, triplet, quintuplet and changing time signatures and <u>Listening Skills</u>: performance of a duet or prepared sung aural tests including singing back notes, melodies, notes from chords and intervals plus scales arpeggios and modes as well as clapping back rhythmic patterns.

There are no unprepared elements (such as unprepared sight reading or aural tests) in these MTB Exams' Practical Grades. Candidates are expected to practice **all** elements to be presented in the assessment (included the published Reading and Listening Skills) as part of their preparation for taking the examination.

#### **Performance Grades:**

Performance Grades comprise the performance of Four or Five Pieces and a Target Duration

- 1. Recital Accuracy/Expression/Technique This is the performance of compositions or arrangements and the skills being assessed here are the ability to play the correct notes and rhythms fluently and the tempo and intonation. Also, the understanding of the appropriate stylistic expectations of the music, expressive elements such as dynamics and phrasing plus any relevant technical ability required to successfully convey the music to an audience such as tone quality, breath control, bow control, shifts across strings, clarity and quality of articulation, other particular techniques relevant to the piece being performed, staccato, legato, accents, technical control of passagework etc.
- 2. **Stagecraft & Sense of Performance –** This assesses the presentation of the recital plus communication with the audience and other performers such as accompanists, engagement with the music and the listener, any verbal communication, posture, deportment, confidence, pace of delivery etc.
- 3. **Programme** This is the substance of the chosen programme including, length, level of content, balance, variety, imagination and how clearly the programme content has been conveyed be this verbally or through a written programme.

Target Durations for Performance Grades are as follows: Grades 1-5

For grades 1-5 Target Durations are a flexible guide to help candidates create a programme of appropriate length, substance and content for each grade. For this reason, performances that deviate from the Target Duration even substantially would only be penalised if this negatively impacted on the level of content.

Gd 1 – 5 minutes

Gd 2 – 6 minutes

Gd 3 – 8 minutes

Gd 4 – 10 minutes

Gd 5 – 12 minutes

#### Grades 6-8

At these levels, it is expected that the performer will be responsible the Target Duration of their programme. It should be a skill which has been acquired over time and candidates should by these levels have the confidence to use Target Durations to benefit their planning. For this reason, from grades 6-8 there is a minimum and maximum time for recitals at each grade as well as a target duration. Performances with a total length outside of these parameters will be penalised.

Gd 6 –Target Duration: 15 minute (Minimum duration 12 minutes – maximum 18 minutes)

Gd 7 – Target Duration: 18 minutes (Minimum duration 15 minutes – maximum 21 minutes)

Gd 8 – Target Duration: 22 minutes (Minimum duration 19 minutes – maximum 25 minutes)

The exact content of the syllabus is available on the website 'syllabus' page and is tailored to the specialisation (e.g. violin, trumpet, piano etc) of the candidate. Although therefore, the sections above are common to all specialisations, the exact content of each section may vary between the syllabuses as appropriate for each specialisation.

#### The method of assessment

Assessment is through a recorded practical examination. It can be delivered with or without a centre. The process for this is as follows:

**Performance Grades:** Performance Grades should always be recorded in video and are made up of 4-5 pieces with a target duration. Start the recording and the candidate should perform all their pieces. The candidate can introduce each piece and/or submit a written programme.

**Practical Grades:** Practical Grades are made up of three sections: Recital, Technical & Musicianship. Contemporary & Pre-grades are made up of just Recital & Technical sections. The requirements for each instrument are listed on the syllabus. Start the recording and the candidate should announce the title and perform each piece in the Recital Section and perform the Technical and Musicianship section requirements as applicable. Sections can be performed in any order but each one must be performed as a whole.

The simplest way to record (or video) and submit an MTB Exam is to use the MTB Exams App on a phone or tablet. The App is available through the App stores on either Android or IOS devices or it can be accessed via the MTB App page on the MTB Exams website. Although using the app is recommended, it is not compulsory and other devices may be used to record an exam and there is a submission portal (page) on the website through which exams recorded on other devices can be uploaded.

Before beginning the assessment, the centre should check they have the following:

- Recording equipment
- List of the scales (if relevant)
- Any music needed in order to deliver the Reading & Listening Skills Section of the assessment (if relevant)

Using the app or alternative recording device please follow the following process:

### **Conducting the exam:**

Once started, the whole exam must be completed in one single recording and not be paused or stopped. Once complete the recording can be submitted via the MTB App (if used) or via the website submit an exam page. You will also need to submit a copy of music used for any Recital pieces and the candidate's ID (for grades 6-8). Please ensure to photograph each page of music used in the exam, (pieces from MTB books do not need to be photographed).

**Audio exams:** (This section is relevant for audio exams only)

- For audio exams a registered audio approved centre must always be present.
- At the start of the recording state the: candidate name, instrument, grade, teacher name and the exam reference number (see top of this sheet). If the exam is being conducted over webcam please also state this and ensure the recording device is in the room with the candidate.
- The teacher must lead an audio exam by asking the candidate to introduce each piece or exercise before it is performed. It is important that both the teacher's and candidate's voices are audible throughout the assessment.
- At the end of the recording the candidate & teacher named above must either verbally state the following or sign and attach a photo of this form to the additional attachments section during the submission process. A copy of the candidate's ID is not required for an audio exam.

# The criteria against which learners' levels of attainment will be measured

The following are the expected levels of expectation at each grade: Depending, whether the Practical or Performance Grade route is being used, relevant elements from the following will apply.

#### **RQF Entry Level -** Pre Grades Introductory & Higher:

Ability to perform very elementary repertoire with very simple technical and musical demands. Also, technical exercises demonstrating elementary control of the very basic techniques associated with their specialisation (e.g. violin, piano etc) and an understanding of very basic reading of rhythm, and aural awareness.

## **RQF Level 1 -** Grades 1-3

Ability to perform simple repertoire with basic technical and musical demands. Also, technical exercises demonstrating basic control of a range of simple techniques associated with their specialisation (e.g. violin, piano etc) and an understanding of simple reading of rhythm, and aural awareness.

#### **RQF Level 2 -** Grades 4&5

Ability to perform straightforward repertoire with straightforward intermediate

technical and musical demands. Also, technical exercises demonstrating a moderate, straightforward level of control of most techniques associated with their specialisation (e.g. violin, piano etc) and an understanding of straightforward reading of rhythms of a moderate difficulty, and a moderate level of aural awareness in straightforward situations.

# RQF Level 3 - Grades 6-8

Ability to perform complex repertoire with sophisticated complex technical and musical demands. Also, technical exercises demonstrating an advanced level of control of the full range of techniques including complex techniques associated with their specialisation (e.g. violin, piano etc) and an understanding of complex reading of rhythm, and a high degree of aural awareness.

#### **Levels of attainment**

The examination is marked out of 100 with a pass mark of 60 Levels of attainment are categorised as follows:

87-100 Distinction

#### **Breakdown of mark allocation**

Because the specific skills vary as appropriate to the specialisation (e.g. violin/piano etc) the mark scheme has slight variations to take account of this. The syllabus clearly explains the mark allocation per element of the examination for each specialisation but the full list of mark schemes are also shown below.

# **Equipment required to deliver the qualification**

In delivering the assessment the centre will make an unedited recording of the whole assessment. Although it is recommended that the MTB Exams App is used for this, any device which will produce this may be used to make the recording. The quality of recording needs to be of sufficient quality, volume and clarity for it to be easily marked by our examiners. If using the MTB Exams App, the exam is submitted directly from the app. If not using the app, the recording is uploaded by the centre as a digital file via the submission route on our website using the 'submit an exam' page. It should ideally be presented as an mp3 or wav file although other file types are acceptable provided the board are able to access it for marking. If a file type proves to be inaccessible, a request for the recording to be sent as an mp3 or wav file will be sent to the centre.

## **Supporting materials**

All printed materials required or supplied to assist in the delivery of the assessment such as any technical section requirements, reading & listening scales etc. can be found on the website 'syllabus' pages.

### Submitting exams for marking

Scans/photos of the music for the recital section and the verification form should be uploaded along with the recording using the app or the 'submit an exam' page on the website. NOTE: For Practical Exams, the verification form should be signed by both the candidate and centre if the verification statements are not read aloud verbally on the recording.

#### Results

All exams submitted are marked by a specialist MTB Exams' examiner. By this we mean that only an examiner who plays or teaches the instrument played by the candidate will mark an exam for that instrument. e.g. a trombone specialist will mark a trombone exam, a violin specialist a violin exam etc.

The result will be emailed to the centre usually within 2 weeks of submission and a certificate posted to the address supplied by the centre after confirmation by the exam board. Certificates will normally be issued/posted within 4-6 weeks of receiving the marksheet. Receipt may vary depending on the speed of the postage delivery service.

# Syllabus guidelines

- All repeats, DC and DS marks should be observed (unless the syllabus specifies otherwise)
- For the recital section of the exam, the candidate should introduce each piece they are about to perform by stating its title.
- The candidate should be asked to play **all** the scales and arpeggios set on the syllabus during the exam (where applicable).
- The candidate should be asked to play all the required technical exercises (as set on the syllabus) during the exam (where applicable).
- The centre may help the candidate tune up before the exam begins. This should be done before starting the recording.
- The composer's dynamics, phrasing etc should be observed in the pieces presented for the recital section of the exam. However, any editorial markings may be altered to allow for a personal interpretation.
- The centre is encouraged to speak to the candidate during the exam to put them at ease or to help them understand what is being requested.
- The recording should not be turned off at any point during the exam until all elements of the assessment have been completed. When using the app, if the recording is accidentally stopped or stops due to a technical issue it must be

resumed as soon as possible and this must be within 5 minutes. Recordings on the app are time stamped so that MTB can track the length of a gap if the recording stops and restarts midway through the exam. Please explain the reason for any stop or restart of a recording using the submission note. MTB Exams may reject a submission for any reason if it is felt that that a recording does not comply to our expectations in this regard. If the app is not used for the recording, it must be in one continuous unedited take and cannot have any extra recorded sections added.

- Candidates are encouraged to practice the sung aural tests or duet (Listening Skills) and Reading Skills tests as part of their preparation prior to taking the examination (where relevant).
- For the duet option (if selected), the other part (i.e. not the candidate) may be performed on any instrument from the same family (wind/brass/strings etc) and octave transpositions made as necessary. A recorded version of the other part (i.e. not the candidate) may be used or it may also be played by the teacher, another pupil or any suitable person.
